On April 26, 2018, the Supreme Court approved amendments to the Federal Rules of Civil Procedure, which will take effect on December 1, 2018.. The following rules were updated: Rules 5, 23, 62, and 65.1. The changes are listed below. New text is underlined while deleted text has strike through.
